Coyote Meadows Site Details

- 50 acres, including:
 - Coyote Creek corridor & trail
 - old railroad ROW, trestle, trail
 - Plateau (capped landfill) w/ views
 - Meadow w/ leased radio towers
 - Gateway area by Story at Senter
- 1 mile to San José State University;
 1½ miles to Downtown;
 1½ miles to the future 28th Street /
 Little Portugal BART station
- Formerly the Remillard brickyard
- Site constraints
 - contam: landfill & former railway
 - sensitive riparian habitat
 - subject to flooding
 - limited vehicular access
- Property is owned by City of San José, zoned "Public Park & Open Space" in the General Plan

Timeline

2016: Coyote Meadows Coalition formed **2017:**

- grant from Open Space Authority
- began site tours, bio-blitzes, cleanups
- released preliminary vision concept and supporting <u>video</u>*

2018:

- released OSA-funded, communitydeveloped <u>Concept Plan</u>*
- engaged with San José departments:
 Parks (PRNS), Office of Economic
 Development, City Manager's Office

2019-2023:

ongoing tours, bio-blitzes, and cleanups
 Next steps:

- seek add'l grants for more community engagement & advocacy development
- coordinate with the City to refine and implement the concept
